Changes in Risk Management Charges

Issue

The Committee on Finance, Personnel & Audit requested additional information on how charges for Risk Management services have changed between the 2014 Adopted and 2015 County Executive Recommended Budgets (October 13 meeting, agenda item #12).

Background

Costs for Risk Management services rise significantly over 2014 due mainly to a spike in workers' compensation claims, representing an increase in costs of approximately \$2.6 million; and an increase of approximately \$1 million in premiums for property insurance. These costs are budgeted in the Risk Management Division of the Department of Administrative Services and are all charged out to other County departments. The amount allocated out to departments in 2014 was \$7 million, the total in the 2015 Recommended Budget is \$11.4 million, an increase of \$4.4 million.
